I. Call to Order – Chair Johnson called the meeting to order at 7:09pm. II. New Business

1. Mitchell Shaney – 410-412 North Windham Road

Mr. Shaney presented his application for a wetlands permit to remove debris and sediment from an existing man-made pond on his property. The pond is approximately 125ft by 75ft. The material will be reused in his garden and under some fruit trees. J. Marsalisi MOVED to receive the application. J. Wagner SECONDED. MOTION PASSED unanimously.

1. Bruce Hussey – 34 Boston Post Road, Willimantic – application for permit to install pipe in drainage ditch

Bruce Hussey wishes to cover this ditch to prevent any contaminants from the business operated nearby from leaking into the nearby river. Discussion about current waste disposal procedures on the site. K. Eves MOVED to approve the application for a wetlands permit to install a pipe in the drainage ditch as presented on plans shown to the Commission on January 14, 2016. J. Marsalisi SECONDED. 
